PORT WATER AREAS IN THE PUBLIC DOMAIN IN WHICH FISHING, SPORTING OR LESIURE ACTIVITIES ARE ALLOWED OR RESTRICTED, AND THE CONDITIONS FOR CARRYING THESE OUT IN THE PORT OF TARRAGONA


Approved by agreement of the Board of Directors of the Tarragona Port Authority on September 30th 2015 and published in the Tarragona BOP No. 238 dated October 15th 2015



The limitations, conditions or authorisations referred to in this document are established without prejudice to the legally demanded requirements, requisites or authorisations in accordance with the regulations governing each particular type of activity, as well as the proprietary rights of occupation of the Port's public domain that will prevail over the same activities, and the constraints that result from Port protection (ISPS) and Critical Infrastructure.

The limitations, conditions or authorisations referred to in this document may be exempt for sporting events, regattas or other occasional group events in any area of the waters of the Port, in the event of prior express authorisation from the Tarragona Port Authority and the Tarragona Harbourmaster, and with fulfilment of the conditions and considerations that these bodies may set.

DESCRIPTIVE AND EXPLANATORY PROVISIONS OF THE AREAS IN WHICH, DUE TO EXCEPTION TO THE RESOLUTION OF JULY 28TH 2015 BY THE TARRAGONA HARBOURMASTER, IT WILL BE POSSIBLE TO CARRY OUT FISHING, SPORTS OR RECREATIONAL ACTIVITIES



In the AREA OF THE PORT'S INTERNAL WATERS AND REPSOL JETTY, marked in red on the attached plan, all types of fishing, sports or leisure activities are prohibited. By way of an exception, the sport of rowing will be allowed from the mouth of the Francolí River to the limit marked by the bridge crossing the pipe rack in the Chemistry dock and which is marked on the attached map. In exceptional cases the limit referred to may be exceeded with express authorisation.

In the **ANCHORAGE AREA**, marked in yellow on the attached plan, all types of fishing, sports or leisure activities are prohibited. By way of an exception, mechanically propelled boats and sailing boats equipped with VHF will be allowed to cross the area without stopping as long as they keep radio watch on Channel 16. During the crossing will have to maintain a separation of no less than 50 metres from any vessel anchored or manoeuvring, keeping away from their course and not obstructing the manoeuvring of these vessels. In no event will sailing vessels have priority over manoeuvring merchant vessels.

In the TRANSIT AREA, marked in orange on the attached map, which includes the access channels to the harbour mouth from outside of the Port waters or from the anchorage area, fishing, sports or leisure activities will not be allowed. By way of an exception, mechanically-propelled boats, jet-skis and sailing vessels equipped with VHF (except for the jet-skis) are permitted to travel across without stopping provided they keep radio watch on Channel 16, with special care and attention being paid in all cases and in navigating, taking account of the high volume of traffic of merchant vessels manoeuvring as they enter and exit the Port. In addition, pleasure craft or other floating structures may cross without stopping provided that they are accompanied by a support motor boat equipped with VHF and provided that the vessel itself keeps radio watch on Channel 16 and prior to starting to cross the aforementioned area, notifies this on Channel 14 (Tarragona Pilots) in order to coordinate the passage of these vessels.

In the **EXCLUSION AREA**, marked in purple on the attached plan, which covers a radius of about 560 meters around the SBM (3 cables), all types of fishing, sports or leisure activities are prohibited, in accordance with that established in the Tarragona Harbour Master's Office Resolution of June 1st 2001, published in the BOPT on June 21st of that year.

In the **TRAFFIC AREA**, marked in green on the attached plan, non-commercial fishing, sports or leisure activities are allowed, provided they are carried out watching and listening at all times and in conditions of safety.

In the CONTAINED AREAS WITH BREAKWATERS, BEACHES AND ROCKS, marked in brown on the attached plan. In the area of the Llevant pier breakwater and the marina's outer protective breakwater, motor or sailing vessels are not allowed to sail and anchor in the 50 first metres from the highest point of the breakwater. In addition, since it does not meet the breakwater security conditions for the accessibility of people, its use as a means of access to the sea for any type of activity is prohibited, except for the crossings and installations authorised by the Port Authority that satisfy the appropriate security conditions for this purpose. In the area of beaches and rocks, the prohibitions and restrictions will be applicable, with the limits and conditions laid down in the legislation concerning coasts and in the Plans for the municipal uses of beaches.

A plan in blue by way of a guide. A strip of buoys with the corresponding access channel may be established during the summer period, inside which the anchoring of boats will not be allowed.
